U.S. Federal Libraries Create Disaster Response Network

The Preservation Directorate and the Federal Library and Information Center Committee (FLICC) of the Library of Congress co-hosted a symposium on February 25, 2008, aimed at creating a cooperative disaster-response network to protect and preserve objects of historic or cultural value in the Washington, D.C. metropolitan area.

Although the Library of Congress and other major facilities in the region each have emergency plans for the protection of national treasures and other key items in their own collections, the goal of the symposium – titled “Safety Net: Networking for Disaster Response” – was to develop a framework for a network of federal libraries that would offer support across their organizations in the event of a disaster in the region.

Alan Aiches, historic preservation specialist with the U.S. Federal Emergency Management Agency opened the session with images of the aftermath of Hurricane Katrina and Rita to set the stage for the day and the necessity of creating an action plan.

Department of Justice (DOJ) Librarian Blane Dessy, whose division experienced building flooding in 2006, described the loss of materials and the human toll the deluge caused. Flooding triggered by heavy June rains inundated not only the sub-basement and basement of DOJ's million-square-foot Robert F. Kennedy Building, he said, but also affected other institutions in the area.

Eric Pourchot, professional development director for the American Institute for Conservation of Historic and Artistic Works, described that group's work to train “go” teams around the country to travel to affected sites and help direct disaster conservation of library and museum materials

An outcome of the gathering was to develop and adopt a charter of principles for a mutual disaster assistance program. Participants in the program will share information and offer aid to one another on a voluntary basis. Work to form the new network is being supported by the Library's Federal Library and Information Center Committee and the International Federation of Library

Associations Preservation and Conservation North American Network.

The Library of Congress Preservation Directorate also sponsored two meetings later in the year: "Preservation Education in the 21st Century" was held in May and a "Summit of Research Scientists in Preservation" in July. For more information, see <http://www.loc.gov/preserv/symposia/schedule.html>.

New Bookbinding Glossary

Ligatus, a new research unit of the University of the Arts London, was recently launched. Headed by book historian Professor Nicholas Pickwoad and assistant director Dr. Athanasios Velios, the Ligatus Research Unit is dedicated to the history of bookbinding, conservation and the use of digital technologies in support of both.

The work of Ligatus has sprung out of the work that has been carried out at the monastery of St. Catherine in Sinai, Egypt. The library of the Monastery holds a unique collection of Byzantine manuscripts and early printed books. Over the last few years, Ligatus has undertaken the exacting task of assessing the condition of the manuscripts, printed books and scrolls, classifying the information using digital technologies. From the analysis of this data, Ligatus has created a comprehensive glossary of bookbinding terms that will act as a platform for the detailed and consistent descriptions of bindings and binding structures. It is the level of research and detail that makes this an exciting new tool. The unique aspect of this glossary is that it is arranged in hierarchies of information based on the structure of books which allows the glossary to work in two directions – from term to object and from object to term so that it will be possible to find terms that a user does not already know. Each term will be accompanied by extensive photographs, diagrams or drawings. The glossary is an ongoing research tool which will be expanded to include bindings beyond those surveyed at St.Catherine's monastery.

It is the aim of Ligatus to finally produce a comprehensive glossary for the handmade book, up to the early nineteenth century. However, Ligatus also hopes this could extend eventually to the early twentieth century. The glossary will be released on the Ligatus website this Autumn: <http://www.ligatus.org.uk/>. It is hoped that the glossary will act as an impetus for book scholars to contribute to the study of binding structures by adding and refining data that will not only enhance the

effectiveness of the glossary itself but will also add to a central database making it possible to have a sufficiently large pool of information that will allow statistical analysis and dating of binding styles and structures.

Ligatus is working with five European partners and hopes to make the glossary available in six different languages. Another rewarding aspect of the glossary is that the descriptive methodology will be available to conservators for recording books that they are working on. However, the glossary is not just for book historians and conservators. It is intended to have practical use for all those interested in and dealing with old books. At first glance, the glossary may appear very detailed and daunting to those not wishing to explore bindings in-depth but the beauty of its hierarchical structure means that users can enter in at what level they require and at the same time a much needed consistency is maintained.

The bookbinding glossary has a wide range of advisors as well as four editors, Maria Argyrou, Georgios Boudalis, Nicholas Pickwoad and Athanasios Velios.

The glossary is just one aspect of the work of the Ligatus Research Unit, which aims to foster focused research into the study of the history of bookbinding and conservation. Placed within the University of the Arts London, Ligatus is also able to offer opportunities for further PhD research and to contribute to the enhancement of the curriculum for relevant courses at undergraduate and MA level.

EROMM Annual Meeting

The 15th annual meeting of the steering committee of EROMM in Göttingen (Germany) was held June 16, 2008.

EROMM (European Register Of Microform and digital Masters) is a consortium of large libraries (or networks of libraries) belonging to 13 European countries, with the aim to promote conservation by microfilming or digitizing and to build and manage a collective catalog of microfilm or digital masters. The goal is to prevent multiple reproductions from different libraries.

The consortium is hosted by the Niedersächsische Staatsbibliothek Göttingen. It contracted with RLIN, OCLC, LAROMM for record exchange. Today it has about 2.8 millions records. The British Library and the Bibliothèque nationale de France are large European contributors.

Among the main goals for this year:

- EROMM is promoting harvesting as its preferred way to collect records of surrogates
- the draft of a new agreement has been accepted by the members of the steering committee; all EROMM partners are requested to sign it this year
- a discussion has begun to decide if EROMM should contain non-printed documents, and particularly iconographical documents.

Preservation Survey Tool for Audio and Moving Image Collections

Columbia University Libraries, USA, has developed and tested a tool to inventory and assess the physical

condition of audio and moving image materials. The "Preservation Survey Tool for Audio and Moving Image Collections" and the accompanying instruction manual are now available for download to anyone interested in surveying a collection at <http://www.columbia.edu/cu/lweb/services/preservation/index.html>.

This survey tool is designed for use by librarians and archivists who are not media experts. It provides a mechanism to develop preservation priorities by recording quantities and types of audio and moving image materials, documenting the physical condition of the media and their housings, collecting information about existing levels of intellectual control and intellectual property rights, and evaluating their potential research value.

Applicable either to an item-by-item inventory or a random-sample survey, the survey tool allows for, but does not require, collection of a great deal of detail about each item. Most fields provide drop-down menus to minimize keying and to assure consistent use of vocabulary. Technical terminology is based on that used by the Audio Engineering Society, Association of Moving Image Archivists, and other relevant organizations.

Survey-wide and collection-specific reports can be generated, as well as lists of collections ranked by research importance and degree of physical damage, and lists of the different media.

Funding to design the survey was provided by the Andrew W. Mellon Foundation.

The Koninklijke Bibliotheek, the national library of the Netherlands, recently published: Robert Gillesse [et.al], "Alternative File formats for storing master images of digitization projects" (March 2008) which focuses on possible alternatives for the use of TIFF format for long term preservation of digital masters to lower costs of storage when carrying out mass digitization projects. For large mass digitization projects, the KB has chosen to use jpeg 2000 instead of TIFF to serve as the preservation masters. From Microfilming to Digitizing

After 10 years of microfilming, Metamorfoze, the national program for paper preservation in the Netherlands, has made a shift to preservation based on digital conversion, so called: "preservation imaging". In early 2007 a draft version of the *Guidelines Preservation Imaging Metamorfoze* was issued and tested by several (inter)national image scientists. In this draft version, special attention is paid to the technical quality standards for preservation scans. Since then, several pilot projects have been started to test the new conversion method all practice.

Farewell to the European Commission on Preservation and Access

In June 2008 Yola de Lusenet, the executive secretary of the European Commission on Preservation and Access (ECPA), announced that ECPA will end its activities on knowledge dissemination and communication in the field of preservation activities in Europe. Since 1994 the ECPA, under the auspices of the Royal Netherlands Academy of Arts and Sciences, has been a central point in Europe to promote the preservation of documentary heritage in Europe. Since the great fire that destroyed the Anna Amalia Library in Weimar in 2004, every year, German libraries and archives organize a national action day for preservation of the written cultural heritage, which usually takes place in the first week of September. This day is a memorial day for the fire in Weimar and is also meant to bring to the attention of the general public the need for preservation and conservation in cultural heritage institutions as well as to highlight the richness of these collections. This year the action day will take place at the University Library of Münster, on Sunday, September 7. Under the title: "Papier Klänge" (the sound of paper) special attention will be given to the Germany-wide restoration and preservation of scores of famous composers such as Bach and Telemann. These historic compositions may have damage from ink and paper deterioration, and damage such as mould and fading from light.

Applications are now being accepted for the Preservation Management Institute 2008-09. The Institute is designed for working librarians and archivists who have preservation responsibilities but limited formal preservation education. The program, located in downtown New Brunswick, New Jersey, includes a full week of classes in fall 2008, another week in spring 2009, and a final week in fall 2009. The weeklong sessions include classroom instruction, some hands-on experiences, and field trips. In-between the three weeks of classes, participants conduct guided preservation planning activities for their home institutions, including conducting a preservation survey and drafting a disaster plan. The instructors are among the most respected

professionals in the field today and are led by Evelyn Frangakis, Chief Librarian for Preservation of The New York Public Library.

April 25th marked Ingeborg Verheul's last work day in the KB, the National Library of the

Netherlands. For the last eleven years, she has been involved in several international initiatives in the field of preservation, digital preservation and digitisation.

IFLA was pleased to announce the appointment of Ingeborg Verheul as its new Professional Communication Officer. Ingeborg, on assignment from the Koninklijke Bibliotheek (KB) has been working at IFLA's headquarters in The Hague since May 2008, on the visibility and over all communication of IFLA, The International Federation of Library Associations and Institutions.

Ingeborg Verheul studied Dutch language and literature at the Free University of Amsterdam, with a specialization in book- and library science. She started work for the KB, the National Library of the Netherlands in 1997.

In the KB's Research & Development Division Ingeborg has held several positions concerning paper preservation, digitization and digital preservation. Policy making and national cooperation in the field of (digital) preservation, corporate communication and knowledge dissemination were her special fields of interest. As of 2006 she managed "Memory of the Netherlands," the Dutch national program for digitizing of cultural heritage for libraries, museums and archives.

Over the years, Ingeborg has been involved in several IFLA activities. Since having coordinated a pre-conference on disaster management for IFLA's Congress 2003, she has been involved in the Preservation & Conservation Section.

For ICABS, the IFLA-CDNL Alliance for Bibliographic Standards, she carried out a research project on the state of the art of digital preservation in 15 national libraries world wide, which resulted in an IFLA publication in 2006 (IFLA Publication Series 119: Networking for digital preservation).

Ingeborg represented IFLA and acted as founding secretary of the Dutch Blue Shield organization in 2000. Currently, she is a member of the IFLA Working Group on Guidelines for Digital Libraries, in which role she drafted an IFLA/UNESCO Manifesto on Digital Libraries (to be published by the end of 2008).

In her new role as IFLA's professional communication officer, Ingeborg will focus on several general professional communication activities within IFLA, involving the Core Activities, IFLA's Sections and the Professional and Governing Board of IFLA as well.

Announcing the appointment, IFLA Secretary General Peter Lor said: "Headquarters is very happy to welcome someone with Ingeborg's communicative

skills and experience to this new position. Ingeborg's networking spirit will be an asset for IFLA to build better connections with partners, keep members better informed and to help us to raise our profile."

Ingeborg commented: "This job is a great opportunity to contribute in a structural way to IFLA's role as a platform of knowledge sharing in the library world and beyond. I do hope that in my new position I can add more value to the advocacy role of libraries in general, by setting up a solid basis for communication and knowledge sharing for IFLA and its members."
